MAIN ACTIVITIES IN PRESENT JOB

Lead IFPRI's research on markets, trade, and institutions, looking at domestic and international conditions determining the efficiency and equity in agriculture and food markets. Research focuses on linking macroeconomic and microeconomic insights to provide innovative, evidence-based policy solutions for food security and poverty reduction. Focus research areas include: making market participation more beneficial for smallholders; reforming trade policy to remove barriers to trade and minimize the negative impact of market shocks on countries with vulnerable growing economies; designing farm policies that achieve domestic food security goals while limiting negative externalities for foreign countries and agents and for the environment; improving access to and efficiency of markets so that the food system is capable of providing more nutritious and safe food for the poor; and policy assessments to optimize investments in sectors such as roads, electrification, water, sanitation, and education that can help improve access to markets and, as a result, boost incomes, nutrition and health outcomes.

MAIN ACTIVITIES IN PREVIOUS JOBS

As Director of Agricultural Development Economics, Rob Vos was responsible for economic analysis to underpin FAO's normative work and policy support on food security and nutrition, resilience, climate-smart agriculture, agri-business development, rural transformations, and food and agriculture policies. Additional responsibilities include production of FAO's flagship publications on the State of Food and Agriculture (2016 issue on climate change, agriculture and food security) and the State of Food Security and Nutrition in the World, as well as for FAO's work on the long-term outlook for food and agriculture and related modelling frameworks.

In a previous position at FAO, Rob Vos was leader of one of the five Strategic Programmes of FAO related to Rural Poverty Reduction. The programme broad together, through an integral approach to rural development, various lines of work aiming at the sustainable improvement of rural livelihoods and the eradication of poverty. Next to leading this strategic programme, he was also the Director of the Social Protection Division of FAO, which focuses on issues of decent rural employment creation, strengthening of rural institutions and producer organizations, gender empowerment policies and social protection in support of food security and rural poverty reduction, as well as coordinator of FAO's cross-cutting work on promoting gender equality and women's empowerment in agriculture and rural settings.

As Director of Development Policy Analysis at the UN Department of Economic and Social Affairs (UN-DESA), Rob Vos headed the main economic and social development policy research division in the UN Secretariat and sometimes informally considered the chief economist of the UN Secretariat (though such a function does not exist formally). Key outputs of the division included two UN flagship publications. The first is the World Economic Situation and Prospects (WESP), published twice a year, which provides analysis of recent world economic trends and forecasts and assesses the implications for the international development agenda. The WESP is a joint publication of UN-DESA, the five UN Regional Commissions and UNCTAD, but coordinated under my direct supervision. The WESP has been credited for foreseeing the global economic crisis and provide early warning regarding the problems that caused the crisis. Rob Vos also managed to introduce the WESP as an input to G-20 Finance Minister deliberations. He also was alternate observer for the UN at the IMF/WB meetings and the International Monetary and Finance Committee from 2005 to 2012, supporting, respectively, the USG for Economic and Social Affairs (until 2010) and the UNDP Administrator (from 2010).

Rob Vos was further responsible for another UN flagship report, the World Economic and Social Survey (WESS), which addresses long-term development challenges. Topics change each year. Under his

supervision the following issues were focus of analysis: Diverging Growth and Development (2006); Ageing and Development (2007); Overcoming Economic Insecurity (2008); Promoting Development, Saving the Planet (on climate change and development) (2009); Retooling Global Development (2010); The Great Green Technological Transformation (2011); Innovative Development Financing (2012); and –partially under my responsibility – Sustainable Development Strategies (2013).

In addition, he was responsible for the substantive secretariat of the long-standing Committee of Development Policy (CDP), a UN body of high-level independent experts who advise the Economic and Social Council on emerging development issues and the UN development agenda. The CDP is also responsible for identifying the eligibility of countries to the list of least developed countries and monitors transition strategies of countries graduating from the list.

He was coordinator of the MDG Gap Task Force since its establishment in 2007. The Task Force is an inter-agency group monitoring delivery on MDG 8 (the global partnership for development), comprising over 20 UN agencies, as well as the World Bank, the IMF, WTO and OECD/DAC. At the request of the UN Secretary-General and the Chief Executives Board of the UN System, he also created a new accountability framework for delivery on MDG-related commitments called the "Integrated Implementation Framework" and which was developed under the umbrella of the MDG Gap Task Force as a system-wide effort.

Finally, he acted as UN-DESA's coordinator of the Secretary-General's UN Task Team for the preparation of the post-2015 UN development agenda, including more than sixty agencies and entities of the UN system and beyond (including the World Bank). He was the lead author of the Task Team's report presented to the UN Secretary General in June 2012.

EXAMPLES OF MANAGEMENT AND LEADERSHIP EXPERIENCE IN OTHER PREVIOUS POSITIONS

Rob Vos was Deputy Rector and Acting Rector of the International Institute of Social of Social Studies of Erasmus University (ISS) in The Hague, Europe's largest institute for development studies. In addition, I was the chair of the *Economics of Sustainable Development* faculty.

During his period at the Inter-American Development Bank (IDB), he co-founded the Bank's Social Development Institute (INDES). INDES aimed to strengthen the policy dialogue with social sector clients. During that period (1994-97), he also set up a region-wide programme for improving living conditions measurement surveys in Latin America and the Caribbean (MECOVI) for which he provided the conceptual framework, mobilized the funding and led its implementation for its inception. With the IDB in the lead, the MECOVI was a joint undertaking with the World Bank and UN-ECLAC and a recent independent evaluation of World Bank research listed the program among key positive contributions to development efforts. During the 1990s, Rob Vos also designed and helped implement poverty and other social indicator monitoring systems in a number of countries, including Ecuador and Bolivia, where these are still in active use for policymaking.

His teaching experience also includes the design and implementation of numerous executive courses, inter alia, in the design and management of social policies and programs and applied economic modeling. Many of these courses involved innovative training formats, including simulation games that would integrate training in negotiation techniques, social policy analysis and assessment of budget and other financing constraints. He developed these teaching innovations and tailored these to fit the needs of participants (including policy makers, experts from donor agencies, diplomats, UN officials, and NGO representatives).
